Miracle Space Heaters No Better than Cheaper Plug Ins

A typical question we receive at Brainerd Public Utilities, "I have seen full page ads advertising space heaters and electric fireplaces for around \$350-\$400. Will these portable space heaters really save 50% on energy bills?"

Infra-Red Space heaters, like all electric heaters, are nearly 100% efficient, and this has been true for decades. The new wonder space heaters being advertised lately are no more efficient than any other electric heater. 1500 watt electric heaters put out enough to heat a 200-300 sq. ft. room and cost about 12 cents per hour to operate. This is true of any 1,500 watt electric heater.

If you read the fine print of the ads for the 'miracle' heaters, it usually states that the heater saves you 50% on your heating bill if you turn off your central heating system or lower your thermostat to 50 degrees and only heat one room at a time.

You can get the same heat from a lightweight 1,500 watt portable space heater, with a fan, for under \$100, at your local hardware store.

Also, some of the ads we've seen tell you to totally shut off your central heating system. Lowering your central heating system too far or shutting it off totally could cause freeze-up of water pipes.

Finally, be safe when using a space heater. Electric space heaters cause an average of 3,000 fires each year in the U.S often because of improper use, according to the National Fire Protection Association.

Frozen and/or Broken Water Meters

It is BPU Policy if a water meter freezes and breaks, BPU will replace it the first time. If it happens again, the customer is responsible and will be billed the cost of a new meter.

Fee for Check Readings and Test/Change Meters

If a BPU customer requests BPU to check the reading of their electric and/or water meter, there will be a \$25 fee for this service if it is requested more than one time, by the customer, within a 12 month period.

In the event a BPU customer requests their electric and/or water meter to be tested and changed more than once in a three (3) year period, the customer will be charged a \$25 fee. If the meter test indicates that the meter is not accurate, the meter will be repaired or replaced, and the \$25 fee will be returned to the customer.

Informational Notice

Brainerd Public Utilities (BPU) routinely monitors Brainerd's public water system for the presence of drinking water contamination. BPU staff took 63 water samples during the month of October. Of the 63 samples tested, 16 percent showed the presence of total coliform bacteria. The standard is that no more than 5 percent of the samples taken may do so. BPU staff flushed the system and the increased repeat samples have shown no coliform bacteria present.
